

**City of Glendale**

4. **POLICE CHIEF'S REPORT ON DEPARTMENT ACTIVITIES**

Hiring: One officer approved for hire was eliminated due to background check. 2 officers were hired in April, one will be hired in Aug (this individual is currently working as the desk clerk and will go to the academy in Aug), one will be hired in Sept. and Dec. each. In March 2020, 2 officers to be hired. Will need a new recruit process in fall of 2019.

Promotions:

June- one Lieutenant and one Sergeant to be promoted

July – one Lieutenant and one Sergeant to be promoted

Sept – one Captain, Lieutenant and Sergeant to be promoted

Feb 2020 – one Sergeant

Lawsuit: City settled lawsuit involving the police department.

DNC: Planning for the 2020 July convention underway. Most of our officers will be working the convention. The city of Milwaukee will cover costs.

Canine Team: A new canine team will be starting in July. The dog is being trained now as a drug (not marijuana) and apprehension dog.
