**Noteworthy Calls for the Week**

**08/23/21 - W Silver Spring Dr/N Green Bay Ave - Pursuit**

A newer model silver Ford Edge exited BMW onto W. Florist and turned s/b onto N. Green Bay Ave. The vehicle quickly accelerated, and a pursuit was initiated. Pursuit was terminated as the vehicle crossed W. Capitol Dr. Vehicle likely entered I43 s/b.

**08/23/21 – 6100blk N Green Bay Ave – Pursuit of Stolen Vehicle**

Security company called regarding suspicious vehicle on lot. Officers located and pursued a fresh steal from the lot, apprehending the driver after a PIT and K9 deployment. Second fresh steal located across the street. Driver admitted to arriving in a stolen Kia and stealing another Kia and fleeing from police. Later transported to CJF.
